

Join us for the 21st Annual Royal Palm Challenge, one of the largest cycling events in Southwest Florida! This two-day event offers distances for every level of rider, and includes an optional SPEED TRAP sprint zone, courtesy of the Lee County Sheriff's Office. Funds raised will go to support nonprofit organizations and programs that promote safe cycling and bicycle advocacy. All rides start and finish at Fort Myers Brewing Company. The first 325 riders to register will receive an exclusive Royal Palm Challenge beer glass.

On Saturday, March 9, we offer 32- and 42-mile rides; on Sunday, March 10, there are four ride lengths to choose from: 15 miles, 40 miles, 62 miles and 80 miles. Lunch is included both days, as part of the full registration. Children under 15 years accompanied by an adult will receive lunch and will ride free. Non-riders may purchase extra meal tickets for \$8 each. Saturday's lunch is served 11 am-1 pm. Sunday's lunch is served 11 am-2 pm.
